OUR GOALS


The purpose of the Community Medical Centers PGY-1 Pharmacy Residency Program is to build on Doctor of Pharmacy (Pharm.D.) education and outcomes to contribute to the development of clinical pharmacists responsible for medication-related care of patients with a wide range of conditions, eligible for board certification and eligible for PGY-2 pharmacy residency training.

The PGY-1 Pharmacy Residency Program has been conducted at Community Regional Medical Center in Fresno, CA since 2002 and at Clovis Community Medical Center in Clovis, CA since 2016. Our multiple-site program provides a wide range practice experiences in diverse settings and increases opportunities to obtain experience in areas of interest. All 5 residents are part of a single program and are able to rotate throughout the health system. Required rotations take place at home base sites: 3 residents at Community Regional Medical Center and 2 residents at Clovis Community Medical Center.

The resident is required to staff scheduled shifts, plus additional shifts based on department needs and resident availability/interest. Target every third to fourth weekend (both days) at Community Regional and every other weekend at Clovis Community (one day).
